1. I participate in the Race at my own risk and responsibility.
2. I am familiar with the regulations of The Race 2024, I accept its provisions in full, and I undertake to adhere to them unconditionally.
3. I am aware of the risks associated with participating in car racing and automotive events.
4. In the event of an accident or any other incident in which I am harmed in any way, I will not make any claims against the persons organizing the Race or those cooperating with them during the Race.
5. I have been instructed on the nature of the Race, the rules of its conduct, and the required behavior during the Race.
6. I undertake to follow the instructions of the persons organizing the Race throughout its duration.
7. I am sober, not under the influence of drugs or substances impairing my ability to operate mechanical vehicles.
8. No mental or physical disorders have been diagnosed in me that would prevent me from driving mechanical vehicles.
9. I accept full and exclusive responsibility for my life and health while on the racing track.

#### I undertake to:

1. **Drive safely, with particular consideration for the safety of other individuals present on the race track.**
2. **Be liable for damages intentionally or unintentionally caused to these individuals or their property as a result of my presence on the track, in the event of my fault being determined by the Organizer.**
3. **Cover the costs of repairing damages to track infrastructure resulting from my fault.**
4. **Not drive against the flow on the track.**
5. **Allow faster drivers to overtake when signaled by a blue flag/semaphore.**
6. **Exit the track upon request of designated personnel or according to agreements made during briefings.**
7. **Signal any malfunction of my vehicle using hazard lights.**
8. **Immediately move onto the grass in case of suspected or observed leakage from my car.**
9. **Yield to cars on the track when exiting the depot onto the track.**
10. **Not exceed the speed limit of 30 km/h in the depot and not cross the white exit line from the depot.**
11. **Not enter the track when the traffic light is red.**
12. **Pay an additional fee of 230 EUR for violating safety rules (for each violation).**

I declare that I am aware that:

1. The organizers of the Competition are not responsible for any actions or omissions of the participants towards each other or third parties during the competition in any respect.
2. Violation of the rules of conduct during the competition in a manner that may endanger the safety of its remaining participants is equivalent to immediate exclusion from participation without the right to a refund of the participant's fee.

I accept and will comply with the provisions of the above declaration and the rules applicable during the competition.

I, the undersigned, pursuant to Art. 81 section 1 of the Act on Copyright and Related Rights of February 4, 1994 (consolidated text: Journal of Laws of 2006, No. 90, item 631, as amended), I consent to the free recording of my image and my car in the form of analog and digital photography, and film material as part of a photo session conducted by persons acting on behalf of the Organizer of The Race during a given ROUND. In addition, I give my free consent for the Organizer, Partners and Sponsors of The Race to distribute the image of me and my car in the form of analog and digital photography as well as film material without territorial and time restrictions via any medium.
